AG Quick Ticket<sup>®</sup> is a web-based life insurance application that allows American General's valued distribution partners to spend more time taking care of customers and less time filling out applications.

Producers can access and complete an online application via [www.agquickticket.com](http://www.agquickticket.com) or through [eStation](#), American General's producer business resource center that provides access to product and client information. AG Quick Ticket is also accessible through [WinFlex](#) and [Vital Term](#).

Once submitted, the application information is electronically transferred to ExamOne. ExamOne will perform a tele-interview for complete Part A and Part B information, obtain wet signatures from the client, and submit the Part A and Part B applications and all ancillary forms to American General for processing.

- AG Select-a-Term<sup>®</sup>
- AG ROP Select-a-Term<sup>®</sup>

In addition, AG Quick Ticket now supports replacement applications in all states except Arkansas and New York
